**Rental time is 10:00 am to 10:00 pm, including set up and cleaning, on the date of the rental.
ALCOHOL IS PERMITTED IN THE SHELTER ONLY, ADDITIONAL \$10.00 FEE IS REQUIRED**

Amenities: 35'x45' enclosed shelter, picnic tables, electricity, no refrigerator, outside water, unattached restroom available nearby, and wrap around deck.

A \$100 refundable deposit is required to reserve the shelter. Rent is \$75 for 10:00 a.m. - 10:00 p.m. Rental is due before the building key will be given to the renter. Failure to comply with the rules found in this agreement may result in forfeit of all or portion of the deposit. Renter must pick up key prior to rental at the GrimesFarm and Conservation Center. Office hours: Monday-Friday 8:30-4:00.

- 1. Building must be cleaned with rental and all belongings out of building by 10:00 p.m. Cleaning includes: sweeping floor, clean tables, wet mop spills. Broom, dustpan, mop and bucket provided. Renter must provide cleaning rags or paper towels and soap.
- 2. Leave garbage in containers provided outside/inside the building. Pickup trash outside of the shelter. Shut and lock windows. Turn off lights and lock doors.
- 3. No nails, tacks, pins, staples, screws are allowed to affix decorations, only blue painters tape may be used to affix decorations. Free standing decorations are allowed. No confetti or artificial flower petals.
- 4. Picnic tables should remain in the shelter or on the deck.
- 5. Shelters cannot be used for personal gain: garage sales, dances, merchandise parties, etc.
- 6. Deposit can either be cash or check, please make a separate check for the deposit.
- 7. I, the Renter, am age 18 or older; will be in attendance; agree to abide by all rules and regulations and comply with state and locate statutes regarding alcohol. I further understand I am responsible for all damages to the building, area of contents.
