All registered campers must review our rules and regulations

CAMPGROUND HOST

Campground Hosts are on duty Memorial Day – Labor Day. Campground Hosts hours will be posted at site #29 and #34.

REGISTERED CAMPERS

All registered campers must be at least 18 years of age & at least 21 years of age if offering alcoholic beverages. You agree that you are making the registration on behalf of yourself and camping party at your campsite. You agree you are fully responsible for the acts, negligence, or omissions of the members of your camping party while utilizing CCCB campground and facilities. Additionally, you agree that you have read and understand the policies and rules at Swan Lake State Park campground. Violation of any state law, county park or recreation area rule or regulation by any member of your camping party is cause for the revocation of the camping permit and the entire camping party shall be required to leave.

COUPONS

WE DO NOT ACCEPT STATE COUPONS. We have camping coupon booklets that can be purchased through our campground hosts or the CCCB office and used during the current camping season. If you are planning on camping more than 7 nights camping coupons are not needed – please use our weekly rate. Camping coupons are not transferable.

REGISTRATION

Check in time is after 5:00 AM and check out time is at 6:00 PM. All CCCB campgrounds are on a self-registration, first-come, first-serve basis. Registration envelopes can be found at either kiosk located on the east and west ends of the campground, if the campground host are not available.

ALL CAMPERS MUST REGISTER THE DAY YOU ARRIVED AND HAVE RECEIPT POSTED AT THE CAMPSITE.

No camping unit of any kind shall occupy any campsite more than **14 days**, the camping unit must leave the campground for one night, unless they occupy sites **1-10, 21-28**, or sites **35 & 36** which are available for long-term camping.

Pre-pay: A person may come out to the campgrounds and prepay for a camping spot, but a vehicle or camping trailer (NOT A TENT) must be parked in the numbered site. A trailer is defined as a unit that has the capability to use water, sewer, & electric hookups.

LONG TERM CAMPERS

Must fill out paperwork with one of our campground hosts the day you arrive.

CAMPSITE

Your campsite should be kept in a clean and orderly manner at all times. Campers shall restore their campsite to the same condition or better than they found prior to leaving. Only **one** picnic table and fire ring per camping site, please do not take these items from other camp sites.

DO NOT PUT GARBAGE IN THE FIRE RINGS – DUMPSTERS ARE LOCATED IN THE CAMPGROUND FOR REFUSE.

PARK HOURS

Swan Lake State Park is open to the public 5:00 AM – 10:30 PM. Quiet hours are from 10:30 PM – 5:00 AM, please respect other park users by keeping noise at a reasonable level. This includes the roadway, all traffic after hours (10:30pm – 5:00am) will be monitored. Any non-register camping visitors must exit the park BY 10:30 PM. Violators will be ticketed for noncompliance.

VEHICLES

Only two vehicles per camp site allowed. All non-registered camping visitors please park outside of the camping area. All motorized vehicles must stay on roadways or in designated parking areas. Park roads are public roads and operators of motor vehicles must be operated by licensed drivers only. Mini bikes and various all-terrain vehicles are prohibited at all times from Swan Lake State Park. UTV, ATV, Side by sides, Golf Carts are not allowed in any of CCCB parks, including all river accesses.

PETS

ALL PETS MUST BE KEPT ON A LEASH OF NO MORE THAN 6FT. AT ALL TIMES. Park users must IMMEDIATELY clean up after their pets. Violators will be issued a \$75 ticket for noncompliance. Pets are not allowed inside Carroll County Conservation facilities.

ALCOHOL

Kegs are not allowed in the campground, at Swan Lake State Park, or any of CCCB parks. All laws of the state of Iowa regarding consumption of alcohol will be strictly observed. Violations of state code will result in expulsion of the campground. Ensure compliance and respecting possession of alcohol by minors and agree to abide by all rules and regulations of the CCCB and State of Iowa.

TENTS

Tents are allowed in non-numbered sites only, however, tents accompanied by a trailer & paying a \$10 tent fee would be allowed on same numbered site. A trailer is defined as a unit that has the capability to use water, sewer, & electric hookups. Either tents or trailers are allowed on lettered sites **A-V**, the nightly fee for the lettered sites because they are electrical sites is \$18 per night. A small tent for kids under the age of 18 of the same family is also allowed with a larger tent at no additional charge.

FIREARMS AND WEAPONS

Firearms and weapons are prohibited at Swan Lake State Park. All Firearms, weapons, and explosives are prohibited in all county parks except during hunting seasons in designated county hunting areas. Fireworks are prohibited at all times.

TREES & SHRUBS

Trees and shrubbery must not be cut or damaged in any way. Berries, fruits, and mushrooms may be harvested in the park.
